Welcome to Xplore Tumbling and Gymnastics LLC, formally known as Tumbling Tots Gymnastics. Listed below is some general information about our program. We look forward to coaching your child and hope this answers any questions you may have.

Registration

- Your child will be evaluated so they are placed in the right level and class
 - We are an ongoing program. There is no contract, if at any time you wish to drop from the program we ask for at least a 2 week notice, therefore we can open that spot for someone else. You can email us directly if that is easier than a written notice.
- If you fail to give a two-week notice you will still be charged and therefore enrolled in the upcoming month.***

Tuition

- Tuition is budgeted on a 48 week year which allows for a Holiday Break in December as well as Spring and Summer Breaks. We do not charge more for 'long' months, nor less for 'short' months.
- Monthly payments are due the 28th of each month for the upcoming month.
- We accept payment in the form of checks, cash, credit or debit cards (we do not take American Express).
- ***\$25 Annual Membership Fee:*** All members of Xplore Tumbling are required to pay a \$25 annual membership fee on the anniversary month of enrollment at Xplore Tumbling and Gymnastics. **** Daycares are not required to pay the registration fee***

Make Up Classes

- We allow 1 make up class per 4 weeks. We understand that things will come up such as illnesses, school functions etc. As much as we would like to accommodate even more, it becomes unfair to those that do make their scheduled class times and it we do not want to overbook any classes.

Prorating

- The only time we pro rate is if you start the class mid month. We feel our prices are already lower than some gyms and that is also why we do not give discount to siblings. If we start pro rating and giving discounts, we would then need to raise our monthly prices.

Move Ups

- We are continually evaluating your child and if your child is ready to move up we will move them up. We do not wait till the end of the month. We believe when they are ready there is no need to wait till the month is over.

Viewing Policies

- Parents are welcome to view classes from the viewing area. **COACHING OR MAKING CORRECTIONS TO YOUR CHILD FROM THE VIEWING ARE WILL NOT BE TOLERATED.** It disrupts the learning process between coach and gymnast and is also very distracting to the other children taking the class as well as the coach.
- Only children enrolled in the class may be on the equipment. Under no circumstances are any children that are not currently enrolled allowed on any of the equipment for any reason.
